August 19, 1991

Regular Meeting

1. The Council of the City of Grove City met in regular session on the 19th day of August, 1991 at 8:00 p.m. in the Council Chambers, City Hall, with the following members present:

2. Mr. Nicholson moved to excuse Mr. Cotton from the meeting; seconded by Mr. Buckley.

6. Speaking to Resolution CR-47-91 was Mayor Stage. He indicated that sewer services for this property would not be available if it were annexed in to the City.

7. Speaking to Ordinance C-55-91 (Trees, Weeds, Shrubs) was Mr. Ron Butane. He expressed concerns that farm land was undeveloped land and provides for wildlife. Cutting down these weeds would no enable wildlife to remain. He also felt that the willingness of farmers to annex into the City would be deterred. Requested that an exemption for a limited period of time be considered.

8. At this time, President Nicholson asked that any New Business to be brought before Council be done so at this time.

9. Ms. Brenda McSade of Casa Boulevard brought forward a petition signed by all Casa Blvd. residents requesting that their street have City water. Mayor Stage accepted and received the petition along with a request for a representative of Casa Blvd. to be chosen and a meeting scheduled to discuss the situation, since Casa Blvd. is currently not within the City limits.

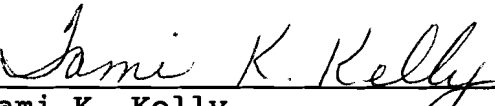

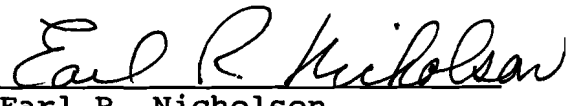
